You don't need to authorise dental treatment in 2015.

Executive:

- Limit of R40 500 per person per calendar year
- Dentistry in the dentist's rooms is paid from Savings and Above Threshold, subject to annual limit.
- The hospital or clinic account for dentistry in a hospital or day clinic is paid from the hospital benefit. Related accounts are paid from Savings and Above Threshold.
- Dentist's and anaesthetists in-hospital are paid at 300% of tariff.

Comprehensive, Priority, Saver:

- Dental appliances and orthodontics limited to R22 900 pp pa on Comprehensive plans and R14 250 on Priority plans.
- Dentistry in the dentist's rooms is paid from Savings and Above Threshold, at 100% of medical aid tariff.
- The hospital or clinic account for dentistry in a hospital or day clinic is paid from the hospital benefit subject to the co-payment of R4400 in a hospital and R2850 in a day clinic. Related accounts are paid from the hospital benefit.
- Dentist's and anaesthetists in-hospital are paid at 200% of tariff on Classic plans and 100% on Essential and Coastal plans.

Core:

- The hospital or clinic account for dentistry in a hospital or day clinic is paid from the hospital benefit subject to the co-payment of R4400 in a hospital and R2850 in a day clinic. Related accounts are paid from the hospital benefit.
- No cover for dental appliances and orthodontics, and for dentistry in dentist's rooms.

KeyCare:

- Basic dentistry (consultations, fillings and extractions) are covered at network dentists on Plus and Access plans. No cover on Core.
- No cover for dentistry in-hospital

Your KeyCare doctor is your first contact for all of your medical needs. You can have two doctors listed for you if you need one close to home and one close to work. You can change your KeyCare doctor up to 3 times per year, and you are allowed one out-of-network doctor visit per year. Your KeyCare doctor will refer you to hospitals or specialists as required, and will authorise these visits with Discovery.

KeyCare Core and Plus members can go to any KeyCare network hospital for emergencies or planned admissions. KeyCare Access members have a second network of hospitals for childbirth and child care.

Chronic medication and care is provided by your KeyCare GP, for 27 conditions and subject to the medicine formulary. You need to collect your medication from your KeyCare GP if they dispense medication, or from a Discovery approved pharmacy.

Discovery has various networks in place to ensure better cover while you are in your Self Payment Gap. This is not available on Classic Comprehensive Zero MSA, Core or KeyCare plans.

Preferred Medicine List:

Available to Executive, Classic Comprehensive and Classic Delta Comprehensive members. Certain medicines on the preferred list will be covered at MedXPress, Dis-Chem, Medi-Rite, Clicks and Pick n Pay pharmacies.

GP Consultations

Unlimited visits for Executive, Comprehensive, and Priority members, and a limited number of visits for Saver members, to GPs in the GP Discovery Network.

External Medical Items

Unlimited from a network of designated suppliers, for Executive, Classic Comprehensive, Classic Delta Comprehensive, Essential Comprehensive, Essential Delta Comprehensive, Classic Priority and Essential Priority members

Blood Tests

Unlimited blood tests at Clicks, Dis-Chem and Pick n Pay pharmacies, for members on Executive, Classic Comprehensive, Classic Delta Comprehensive, and Classic Priority plans. The Discovery pathology form must be used for these tests.

Antenatal consultations and 2D pregnancy scans

Unlimited for members on Executive, Classic Comprehensive, Classic Delta Comprehensive, and Classic Priority plans, and a limited number for those on Classic Saver and Classic Detail Saver, at gynaecologists or obstetricians who have a payment plan with Discovery.
